What is Human Trafficking?

The use of **force**, **fraud**, or **coercion** to obtain some type of **labor** or **commercial sex act**.

HSI Blue Campaign



It affects **everyone**, regardless of sex, age, gender, race, or nationality.

HSI Blue Campaign

If a victim is **under the age of 18**, any act of commercial sex is considered to be trafficking, regardless of the use of force, fraud, or coercion.

Types of Human Trafficking



Sex trafficking- using force, fraud, or coercion to obtain a commercial sex act

Examples: escort services, pornography, brothels, massage parlors

Labor trafficking- using force, fraud, or coercion to obtain labor

Examples: restaurant workers, landscaping, factory workers, construction

The Data



The U.S. is the **#1 consumer** of sex trafficking.

US Institute Against Human Trafficking

The average age of child sex trafficking victims is **12**.

US Institute Against Human Trafficking

Human trafficking is a \$150 billion dollar industry.

Polaris

Only **2.7% of human trafficking cases** are prosecuted.

Polaris

Action-Means-Purpose (AMP) Model

Action-Means-Purpose (AMP) Model can help explain the federal law for human trafficking.

The trafficker takes **ACTION** (*transports, recruits, provides*), then employs the **MEANS** (*force, fraud, or coercion*) for the **PURPOSE** of compelling a victim to provide labor or a commercial sex act.

At a minimum, one of each element (AMP) must be present to establish a human trafficking situation.

Where Does Trafficking Occur the Most?

Labor Trafficking:

- Recreational Facilities
 - ex. golf courses, summer camps
- Health Care
 - ex. nursing homes, health aides
- Carnivals
- Forestry
 - ex. logging
- Factories & Manufacturing
 - ex. food processing, clothing industry
- Commercial Cleaning Services
 - ex. janitors, housekeepers
- Landscaping
- Hotels & Hospitality

- Construction
 - ex. welding, roofing, carpentry
- Health & Beauty Services
 - ex. nail or hair salons
- Agriculture & Animal Husbandry
 - ex. dairy farms, corn fields
- Peddling & Begging
 - ex. sell candy, solicit donations
- Restaurants & Food Services
- Traveling Sales Crew
 - ex. selling fraudulent products
- Domestic Work
 - ex. live-in nanny or housekeeper

Where Does Trafficking Occur the Most? (cont.)

Sex Trafficking:


- Pornography
- Residential Brothels
 - ex. trafficker gives card with brothel location information
- Outdoor Solicitation
 - ex. pimp forcing young girls to meet men outside in their cars
- Remote Interactive Sex Acts
 - ex. webcams, phone sex
- Personal Sexual Servitude
 - ex. girl is sold to pay off family debt
- Escort Services
 - ex. women delivered to a location

Sex and Labor Trafficking:

- Arts & Entertainment
 - ex. exotic dancing, modeling, sports
- Illicit Activities
 - ex. drugs, firearms, etc.
- Bars & Strip Clubs
- Massage Parlors




